- To designate \*one healthy family member or close friend to visit the resident.
- To schedule the visit in advance, online [www.fairhaven.bc.ca](http://www.fairhaven.bc.ca) or by contacting the Recreation Department
  - Burnaby Recreation: 604 435-0525, ext 351
  - Vancouver Recreation: 604 433-2939, ext 115
- To be screened by a Fair Haven Homes team member upon arrival. A screening questionnaire must be completed each time you visit and your temperature will be taken.
- To perform hand hygiene when entering and leaving the home, when entering and leaving the designated visiting space, and during the visit, as needed
- To wear a mask at all times. If you do not have your own mask, we will provide one.
- To wear additional Personal Protective Equipment (PPE) as requested by the Fair Haven team member. You may be asked to wear a gown if you have travelled to the greater community before your visit or if you wish physical contact with your loved one.
- The visit will occur in the designated outdoor or indoor space, depending on yours and the resident's preference.
- To go directly to and from the designated visiting area. Access to the common areas, dining room, and other spaces is not permitted at this time to minimize contact with Fair Haven team members and other residents during your visit.
- To use the public washroom identified.
- To not eat or drink during the time you are with your family member as you are required to wear a mask at all times. You may bring in food and beverages according to the Fair Haven Personal Items and Gifts guideline and upon discussion with the Nurse Manager.
- The delivery of items to other residents is not permitted.
- No pets are permitted.

**Failure to complete the above requirements may lead to discontinuation of the visitation arrangements. Please Initial\_\_\_\_\_.**
